Terms and conditions:

I. General Terms of Use

- A. The Agreement is NOT an insurance policy.
- B. **The Agreement is valid only for the listed Horse and Member(s) and is non-transferrable.**
- C. The Agreement covers only the services listed above.
- D. All other services or inventory provided outside of the above listed services must be paid in full at the time the services or inventories are rendered.

II. Service Provider

- A. Services are to be rendered solely by the agents, employees, or representatives of Clover Valley Veterinary Services, PLLC.

III. Term of Agreement

- A. Agreement is set for 12 months based on the start date on this Agreement.
- B. Services do not carry over from year to year.

IV. Automatic Renewal

- A. Agreement will automatically renew on anniversary of start date.
- B. There is an annual enrollment fee of \$145 due at the start of each Agreement year.

V. Payments

- A. Monthly payment installments will be charged to the Member(s) credit card on the 2<sup>nd</sup> of each month.
- B. **There will be a \$40 fee assessed for any declined cards or over-drafts.**
- C. Member(s) are responsible for providing updated payment information to Clover Valley Veterinary Services, PLLC.

VI. Cancellation/Refund Policy

- A. Member(s) can cancel within 72 hours for full refund of all fees less the undiscounted value of services redeemed.
- B. After 72 hours the enrollment fee is non-refundable.
- C. Clover Valley Veterinary Services, PLLC reserves the right to cancel plans at any time and for any reason; CVVS will waive all future payments under the plan contract and release the Member(s) from the contract in-full.
- D. Member(s) can cancel at any time but there may be monies due based on the non-discounted value of services already redeemed.
  - Cancellation options:
    - i. If fewer services have been redeemed than monies paid, Member(s) can cancel plan; CVVS will keep enrollment fee and all monthly fees paid to-date.
    - ii. If the non-discounted value of services redeemed exceeds fees paid to date, Member(s) can pay the balance due based on retail value of services OR immediately pay the total monthly installments for the plan year in full.
    - iii. If Member(s) paid in full at the time of enrollment, the practice will refund the greater of one-twelfth (1/12) times the number of full months remaining in the plan year OR the full annual fee minus the non-discounted price of all services redeemed under the plan.

VII. Changes to Plans or Pricing

- A. CVVS has right to change services and/or fees upon renewal, but must notify Member 30 days prior to renewal date if changes will be made

VIII. Default/Collections Policy/Collections Fees

- A. Agreement is considered void and all fees are due and payable after 60-days of default.
- B. Member(s) account will be referred to a collection agency after 90-days of default.
- C. All collection costs and legal fees shall be paid by the Member(s).

IX. Multiple Members

- A. All signing Members are considered joint and severally liable for damages incurred in breach of the Agreement.
